S. R. O. Explanatory Note

(This does not form part of the Notification but is intended to indicate its general purport).

According to Notification S. R. O. No. 684/76 published in the Kerala Gazette Extraordinary No. 378 dated 25th June, 1976 the term of the office of the Presidents and Members of Administrative Committees of 113 Panchayats and the Special Officers for 4 Panchayats has been extended upto 31-12-1976. The Panchayat General Elections proposed to be conducted in December, 1975 was postponed sine-die. This notification is intended to extend the term of the existing Panchayat Administrative Committees in 119 Panchayats and Special Officers in 4 Panchayats for a period of six months beginning with effect on and from the 1st day of January 1977 and ending with 30th June, 1977. This notification is intended to achieve the above object.
